Addendum

Charity Match Fee Waiver Request Policy

Purpose

The purpose of this policy is to establish a clear and consistent process for requesting the waiver of range fees for shooting matches conducted in support of charitable causes. This policy ensures that requests are reviewed transparently and that any fee waivers granted by the Club are consistent with the mission and financial responsibilities of Rio Salado Sportsman's Club.

Policy

1. **Board Approval Required**

Any request for the waiver of range or facility fees associated with a match or event benefiting a charitable organization must be submitted to and approved by the Board of Directors prior to the event.

2. **Submission Timeline**

Requests for a charity match fee waiver must be submitted to the Board of Directors no less than sixty (60) days prior to the scheduled date of the match or event.

3. **Required Information**

The request must include sufficient detail for Board review, including but not limited to: The name and description of the charitable organization benefiting from the event.

- The purpose of the charity match and how proceeds will benefit the identified organization.
- The date, division, and scope of the match or event.
- Any additional information requested by the Board to evaluate the request.

4. **Legacy Charity Matches**

Charity matches with an established history of benefiting a recognized charitable organization that may be designated by the Board as a Legacy Charity Match. The Board may approve a range fee waiver for a period of up to two (2) years for such events, subject to periodic review.

5. **Extent of Fee Waiver**

The Board of Directors may approve a full or partial waiver of range or facility fees at its discretion per Policy 15.

6. **Charitable Donation Classification**

Any approved waiver of range or facility fees shall be considered a charitable donation made by Rio Salado Sportsman's Club and shall be administered in accordance with Policy & Procedure #15 and applicable Club financial policies.

7. **Final Authority**

The decision to grant, deny, or modify any charity match fee waiver request rests solely with the Board of Directors.
